MEETING MINUTES

Introductions

Facilitated discussion

After the presentations, the workgroup discussed many topics related to the material presented and what these findings may result in to achieve the needed salt reduction. Steve Whitman facilitated this discussion. The comments generally focused on potential solutions, and largely on how regulations and funding will come into play. The main points of discussion included:

- Timeline for regulations once the TMDL is complete, and if implementation could be delayed – *it is possible*
- Timeline for funding, and the projects that may qualify for funding
- Concern about retroactively funding projects, and salt sheds qualifying for funds – *not likely*
- Timeline for behavioral change
- Forcing versus leading change
- Have regulations in place to dictate the level of service during winter maintenance along with social marketing toward the public
- Using the workgroup over the next few meetings to develop the funding criteria
- Concern over the value of focus group results
- Questions related to money that could be spent on the private sector and private properties

- Salt credit trading and other incentives to consider rather than regulations

Future Meetings
